Event Information: This is a family-friendly public event within the master planned community of Fall Creek which contains approximately 2,700 homes. Please plan your preparation and selling of products/services accordingly. Vendors of all ages and experiences are welcome.

Application Information: Submit your completed application form with the non-refundable application fee of \$10.00 to the Fall Creek Clubhouse at the address above. Payment can be made by money order or personal check made out to "Fall Creek SEC". Only applications submitted with fee will be accepted and considered. Registration closes on Friday, November 20, 2020, no exceptions.

Little Elves: A designated area for Little Elves is available for a limited number of child vendors. They will receive the same set-up materials and must abide by the same rules. Supervision is required by an adult not selling their own goods or services. Multiple children may be assigned to one booth. Little Elves vendor registration is \$5.00.

Products & Pricing: All items must be new and in good condition. Holiday themed items are encouraged but not required. Each vendor is responsible for pricing their goods/services and for the transaction of payments, i.e. adequate change for cash purchases and/or equipment for credit/debit card transactions.

Punctuality: All vendors should arrive to set-up no earlier than 7:00am and no later than 8:30am on Saturday, December 5, 2020. Vendors should be ready to begin selling at 9:00am sharp.

Booth Set-up & Clean-up: Vendors will be provided with one 10x10 covered space furnished with one table, one folding chair, and one red plastic table cover. Vendor space will be on an asphalt parking lot. Stakes are prohibited for displays or any other purpose. The Event Director reserves the right to request a vendor to change their set-up if deemed unsuitable in any way.
