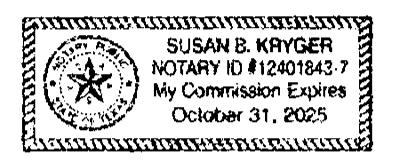

## RECITALS:

- 1. The property encumbered by this Policy is that property initially restricted by the Declaration of Covenants, Condition and Restrictions for Fall Creek Single Family Residential Areas, recorded under Clerk's File No. V338181 in the Official Public Records of Harris County, Texas, as same has been and may be amended and supplemented from time to time ("Declaration"), and any other property which has been or may be annexed thereto and made subject to the authority of the Association.
- 2. Reference is hereby made to the Declaration for all purposes, and any and all capitalized terms used herein shall have the meanings set forth in the Declaration, unless otherwise specified in this Policy.
- 3. Article II, Section 7 (d) of the Declaration gives the Board the authority to establish rules and regulations.
- 4. Section 204.010 (a) (6) of the Texas Property Code provides that the Board "may regulate the use, maintenance, repair, replacement, modification and appearance of the subdivision."
- 5. Pursuant to the authority in the Declaration, the Board of Directors of the Association (the "Board") hereby adopts, on behalf of the Association, this Vehicle Parking and Storage Policy for the purposes of establishing a uniform and systematic procedure to address the parking and storage of vehicles in the subdivision.
- 6. The Board does hereby adopt this Policy, which shall run with the land and be binding on all Owners and Lots within the Fall Creek subdivision ("**Subdivision**").
- 7. This Policy replaces any previously recorded or implemented policy that addresses the subjects contained herein.

### I. VEHICLE PARKING AND STORAGE POLICY

Article VII, Section 9 of the Declaration limits the parking and storage of vehicles within the Subdivision. In addition to the limitations provided in the Declaration, the following rules apply to the parking and storage of vehicles in the Subdivision:

## 1. <u>Permitted Vehicles:</u>

"Permitted Vehicles" may include passenger automobiles, passenger vans, pick-up trucks (each of the foregoing having no more than two (2) axles) and motorcycles that: (i) are in operating condition; (ii) are qualified by current vehicle registration and inspection stickers; and (iii) are in regular use as motor vehicles on the streets and highways of the State of Texas. The Board has the sole discretion to determine whether a particular vehicle is a Permitted Vehicle.

Permitted Vehicles may be parked on the driveway of a Lot or inside a garage or enclosure approved by the ARC. Any vehicle that does not satisfy the foregoing requirements must be completely concealed from public view inside a garage or enclosure approved by the ARC, with the exception of temporary parking of Commercial Vehicles and Recreational Vehicles.

#### 2. <u>Commercial Vehicles:</u>

"Commercial Vehicles" may include cars, panel vans and pick-up trucks used in a business enterprise, including a home-based business, mobile business, tow trucks, plumbing service vehicles, vehicles displaying commercial signage, as well as associated machinery, trailers, or equipment. The Board has the sole discretion to determine whether a particular vehicle, associated machinery, or any signage related thereto is commercial in nature.

Article VII, Section 1 of the Declaration prohibits the existence or operation of any business activity within a Single Family Residence unless it: (a) is not apparent or detectable by sight, sound, or smell from outside the Lot; and (b) if the business activity is not consistent with the residential character of the Subdivision. The parking or storage of a Commercial Vehicle on a Lot or Street by an Owner or Occupant in connection with a business enterprise violates the Declaration because it is not consistent with the residential character of the Subdivision.

Commercial Vehicles may be temporarily parked on the driveway of a Lot for the purposes of construction, repair, or maintenance related to a Single Family Residence or Lot, or for delivery services, but only for the time necessary for such purpose, unless a prior written request is received by the Board and a temporary parking permit has been issued by the Board.

An Owner or Occupant shall not park or store a Commercial Vehicle on a Lot or on the Streets at any time. The parking of any other Commercial Vehicle will only be permitted if such commercial vehicle is completely concealed from public view inside a garage or enclosure approved by the ARC.

## 3. Recreational Vehicles:

"Recreational Vehicles" may include trailers, RVs, motor homes, campers, golf carts, four-wheelers, mini-bikes, scooters, go-carts, buses, dirt motorcycles, buses, vans, neighborhood electric vehicles, jet skis, and boats. The Board has the sole discretion to determine whether a particular vehicle is a Recreational Vehicle.

One (1) Recreational Vehicle with not more than two (2) axles may be temporarily parked on the driveway of a Lot for up to forty-eight (48) consecutive hours for loading and unloading purposes only, unless a prior written request is received by the Board and a temporary parking permit has been issued by the Board. A Recreational Vehicle may be stored on a Lot as long as the Recreational Vehicle is completely concealed from public View inside a garage or enclosure approved by the ARC.

### 4. Vehicles in General:

This subsection applies to all vehicles, including Permitted Vehicles, Commercial Vehicles and Recreational Vehicles, as same are described in this Section. No vehicle may be parked on a landscaped area on a Lot, on another Lot, or a Common Area that has not been designated for parking. Provided, however, this provision does not apply to vehicles that may be parked on a landscaped Common Area at the direction of the Association or its designees. Driveways may not be used to rebuild or repaint vehicles.

#### 5. Enforcement:

Violations of this Policy will be considered a violation of the Dedicatory Instruments governing the Subdivision. After proper notice, the Association shall have the authority to send demand letters, levy fines for any violations of this Policy, and/or enforce this Policy by the initiation of legal proceedings seeking injunctive relief and/or damages, attorney's fees, costs of courts, and all other remedies, at law or equity, to which the Association may be entitled. The Board may enforce this Policy in accordance with the remedies contained herein; however, these remedies are not exclusive. The Association also has all other remedies available at law or in equity. Failure to enforce any violation of this Policy by the Board shall not constitute waiver of the right to enforce any future violations.
